Certificates, ID cards, medals, letters and recognitions may be issued only after approval and verification. BCA may correct, cancel, revoke or reissue any certificate or recognition where data is incorrect, payment fails, eligibility is not met, or misuse is detected.

Website content, forms, policy documents, brochures, images, videos, logos, graphics, templates and training material are provided for legitimate BCA use. Downloading a public document does not grant ownership or permission to alter or misuse BCA branding.

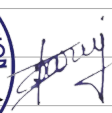
